EXPLANATORY STATEMENT PURSUANT TO THE PROVISIONS OF SECTION 102 OF THE COMPANIES ACT, 2013

Item No. 4 :

Shri Arun Kumar Garg was appointed as an additional director on 30-04-2011 and his this appointment was subsequently confirmed at the Annual General meeting held on 28th September 2011. He was an independent director liable to retire by rotation and as such reappointed at last year's Annual General Meeting on 29th September 2016. He met the criteria of independence as provided in the Act. Now under the Companies Act 2013 an Independent director need not to retire by rotation and is to hold office for five years without retirement so this is being regularised.

The Company has received notice in writing under the provisions of Section 160 of the Companies Act, 2013, from a member along with a deposit of Rs. 1,00,000/- proposing the candidature of Shri Arun Kumar Garg for the office of Non Executive Independent Director. The notice received under section 160(2) is available for inspection during normal business hours on any working day of the Company.

The Company has received from Shri Arun Kumar Garg consent in writing to act as Non Executive Independent director in From DIR-2 pursuant to Rule 8 of Companies (Appointment & Qualification of Directors) Rules 2014, (ii) intimation in Form Dir-8 in terms of Companies (Appointment & Qualification of Directors) Rules, 2014, to the effect that he is not disqualified under sub-section (2) of Section 164 of the Companies Act, 2013, and (iii) a declaration to the effect that he meets the criteria of independence as provided in sub-section (6) of Section 149 of the Companies Act, 2013.

In the opinion of the Board of Directors, Shri Arun Kumar Garg (DIN 00161007), the Independent Director proposed to be reappointed, fulfils the conditions specified in the Act and the Rules made thereunder and he is independent of the Management. Shri Arun Kumar Garg is a Chartered Accountant and in view of the back ground and his valuable experience in investment strategies and a solid understanding of Stock and Commodities Market Operations it will be in the interest of Company to reappoint him as Non Executive Independent Director. The Board considers that his association would be of immense benefit to the Company and it is desirable to continue to avail his services as an Independent Director.

The said Non Executive Independent Director is not related to any of the Directors or Key Managerial Personnel (including relatives of Directors or Key Managerial Personnel) of the Company in terms of Section 2(77) of the Companies Act, 2013.

None of the Directors and Key Managerial Personnel of the Company (including relatives of directors or Key Managerial Personnel) other than the respective Non-Executive Independent Director himself is concerned or interested, financially or otherwise, In this resolution.

2. FINANCIAL PERFORMANCE & OUTLOOK

Financial performance of the company for the year under review is obvious from the aforesaid results which are slightly better than last year but below expectations. Your company mainly operates in Capital Markets and Commodities markets by way of arbitrage, trading and investment activities on its own account. The markets remained volatile during the year. Further, demonetization during the year also affected the economy. The company is always on the lookout for alternative avenues for business opportunities. The funds of the company remained idle off and on & therefore deployed for earning interest income. Rollout of GST was expected during the year and this too led to uncertainties of future operations. The company is managing various risks by maintaining a conservative financial profile and by following prudent business and risk management practices. It is expected that our markets should remain less volatile and stable. Medium term to long term growth prospects look positive in view of the Government's efforts to bring in reforms. Barring unforeseen circumstances, we expect better results in times to come.

3. DIVIDEND

Your Directors feel that it is prudent to plough back profits for the company's future growth. Therefore, your Directors do not recommend any dividend for the year ended 31st March, 2017.

4. TRANSFER TO RESERVES

The Company has transferred an amount of Rs. 1,05,000/- to the Statutory Reserve Fund under section 451C of the RBI Act 1934 and Rs. 3,50,000/- to the General Reserve for the Financial Year 2016-17 out of Profit and Loss Account for the year.

5. CHANGE IN THE NATURE OF BUSINESS

There was no change in the nature of the business of the Company during the Financial Year 2016-17.

6. SUBSIDIARY COMPANIES

The Company did not have any Subsidiary Company or any joint ventures during the year under review.

ANNEXURE - III REMUNERATION POLICY

Remuneration Policy for Directors, Key Managerial Personnel and other employees

This remuneration policy has been prepared pursuant to the provisions of Section 178(3) of the Companies Act, 2013 and Clause 49 of the Listing Agreement. In case of any inconsistency between the provisions of law and this remuneration policy, the provisions of law shall prevail and the company shall abide by the applicable law.

This policy has been framed keeping in view the nature of its activities, size, resources and its capacity to pay.

Key principles governing this remuneration policy are as follows:

Remuneration for Independent Directors

- Independent Directors are to be paid sitting fees (for attending the meetings of the Board and of committees of which they may be members). Quantum of sitting fees may be subject to review on a periodic basis, as required. In addition to the sitting fees, they are also eligible for out of pocket expenses incurred for attending the Board Meetings and Committees of the Board.
- Overall remuneration (sitting fees) should be fair and reasonable keeping in view the nature and size of the company's activities.

Remuneration for Managing Director (MD) / Whole Time Director / KMP/ Rest of the employees
