Notice is hereby given that the 40th Annual General Meeting of Capital Finvest Limited will be held on Monday, 23rd Day of September, 2024 at 11.00 A.M. at the Registered Office of the Company at 1002, Arunachal, 19 Barakhamba Road, New Delhi - 110 001, to transact the following business:

ORDINARY BUSINESS

1. To consider and adopt the Audited financial statement of the company for the financial year ended March 31, 2024 and the Reports of the Board of Directors and the Auditors thereon.
2. To appoint a director in place of Shri Lalit Kumar (DIN 00059732), who retires by rotation and, being eligible offers himself for re-appointment.
3. To ratify appointment of M/s Sudhir Agarwal & Associates (Formerly M/s S R D P & CO.), Chartered Accountants (Firm Registration No. 509930C) as the Statutory Auditors of the Company to hold office from the conclusion of this Annual General Meeting to the conclusion of the next Annual General Meeting of the Company on such remuneration as shall be decided by the Board of Directors or any Committee thereof.

SPECIAL BUSINESS

4. To reappoint Smt. Neeta Goel (DIN 07158388) as Non-Executive Director and in this regard to consider and, if thought fit, to pass, with or without modification(s), the following resolution as a **Special Resolution**:
"**RESOLVED THAT** pursuant to Section 149, 152 and other applicable provisions, if any, of the Companies Act, 2013 "(the Act)" read with the companies (Appointment and Qualification of Directors) Rules, 2014 and the other applicable Rules made there-under (including any statutory modification(s) or re-enactment thereof for the time being in force) read with Schedule IV to the Companies Act, 2013, Smt Neeta Goel (DIN: 07158388) whose term of office expires at the ensuing 40th Annual General Meeting and in respect of whom the Company has received a notice in writing from a member under Section 160 of the Companies Act, 2013, proposing her candidature for the office of Director, be and is hereby reappointed with effect from the conclusion of this Annual General Meeting till the conclusion of the 45th Annual General Meeting as Non Executive Director of the Company, liable to retire by rotation."
5. To reappoint Shri Rattan Singhanian (DIN 00147685) as whole time Director and in this regard to consider and, if thought fit, to pass, with or without modification(s), the following resolution as a **Special Resolution**:
"**RESOLVED THAT** pursuant to the provisions of Sections 196, 197, 198 and any other applicable provisions, if any, of the Companies Act, 2013, the Companies (Appointment and Remuneration of Managerial Personnel) Rules 2014 read with Schedule V of the said Act and Article 95 and 127 of the Articles of Association of the Company (including any statutory modifications and re-enactment thereof, for the time being in force) and as per the recommendation of the Nomination & Remuneration committee and subject to the consent of the members of the company by way of a Special Resolution at the forthcoming Annual General Meeting, Shri Rattan Singhanian (DIN : 00147685) be and is hereby re-appointed as the Whole Time Director of the Company for a further period of three years with effect from 1st April 2024 to 31st March 2027, not liable to retire by rotation, on the terms as under :
 - (a) **SALARY** : Upto a maximum of Rs. 10,00,000/- per month including dearness allowance and all other allowances with authority to the Board to fix the salary within the above maximum amount from time to time. Initially with effect from 1st April 2024 salary to be Rs. 3,00,000 (Three Lakh) and Rs. 4,00,000/- (Four Lakh) with effect from 1st October 2024 and thereafter annual or periodic increments to be decided by the Board within the above limit.
 - (b) **PERQUISITES**:
 - i) The company shall provide the Whole Time Director car with driver for official use as well as for self use or where the car is owned by him then incur/reimburse the expenditure incurred by him, the value of this perquisite to be determined as per Income Tax Rules.
 - ii) Reimbursement of expenditure actually incurred by him on his medical treatment or the treatment of any member of his family to the extent exempt from tax under the Income Tax Act, 1961.
 - iii) Reimbursement of medical Insurance Premium paid by him on his health or on the health of any member of his family under any scheme approved u/s 80 D of the Income Tax Act, 1961.

- iv) Gratuity payable at a rate not exceeding half a month's salary for each completed year of service provided and it shall not be included in the computation of the ceiling on remuneration in any financial year if the Company has no profit or its profits are inadequate in that financial year.
- v) The company will provide one telephone and one internet connection at his residence for the business purposes of the company or pay the expenses for the telephone and one internet connection presently installed at his residence. He shall however reimburse the company for personal long distance telephone calls. The company would reimburse or pay expenses of one mobile phone.

He shall not be entitled to any sitting fees for any Board / committee meeting.

The company would reimburse or pay all expenses incurred in the performance of his duties for the purposes of the Company's business.

Notwithstanding anything herein contained, either party shall be entitled to determine his appointment by giving three months' notice in writing in that behalf to the other party and on the expiry of the period of such notice, his appointment shall stand terminated. The company shall also be entitled to terminate his appointment on giving him three month's salary as specified above.

RESOLVED FURTHER THAT in the event of any loss or inadequacy of profits in any financial year during his tenure, the Company shall pay Shri Rattan Singhania, the remuneration by way of salary and perquisites or any other allowances as specified above and in accordance with the limits specified under the Companies Act, 2013 (including any statutory modifications or re-enactments thereof, for the time being in force) or such other limits as may be prescribed by the Government from time to time in this regard, as minimum remuneration.

RESOLVED FURTHER THAT Shri Arun Kumar Garg - Director of the Company or Ms. Bhavna Seth - Company Secretary of the Company be and are hereby severally authorised to file the necessary returns with the Registrar of Companies, NCT of Delhi & Haryana and to do all such acts, deeds and things and to take all such steps as may be necessary, proper or expedient to give effect to this resolution."

13. SEBI has recently mandated furnishing of Permanent Account Number (PAN), KYC details (i.e. Postal Address with pin code, email address, mobile number, bank account details) and nomination details by holders of securities. Effective from January 01, 2022, any service requests or complaints received from the Member will not be processed by RTA till the aforesaid details / documents are provided to RTA. Members holding equity shares of the Company in physical form are again requested to kindly get their equity shares converted into demat / electronic form to get inherent benefits of dematerialization and also considering that physical transfer of equity shares / issuance of equity shares in physical form have been disallowed by SEBI.

14. Voting through electronic means:

Pursuant to Section 108 of the Companies Act, 2013, and Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company is pleased to provide its members the facility to exercise their right to vote by electronic means.

The instructions for shareholders voting electronically are as under:

- (i) The voting period begins on 18th September, 2024 at 11.00 A.M. and ends on 22nd September, 2024 at 5.00 P.M.. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of 16th September 2024 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/ retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility. Pursuant to abovesaid SEBI Circular, Login method for e-Voting **for Individual shareholders holding securities in Demat mode** is given below:

NOTES TO THE FINANCIAL STATEMENTS AS AT 31ST MARCH, 2024

1 Corporate information

The company is mainly dealing in stocks, securities and commodities and also sometime gives inter corporate loans and advances. The Company does not have any subsidiary or holding company.

2 Significant accounting policies

(1) Basis of preparation of financial statements

These standalone financial statements have been prepared in accordance with Indian Accounting Standards ("IndAS") notified under section 133 of the Companies Act 2013 ("the Act"), read with the Companies (Indian Accounting Standards) Rules, 2015 as amended under the Companies Act 2013 and under the historical cost convention on the accrual basis except for certain financial instruments which are measured at fair values, and on the basis of accounting principle of a going concern in accordance with generally accepted accounting principal (GAAP). Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use. The financial statements are presented in Lakhs or decimal thereof unless otherwise specified.

(2) Revenue from operations

Interest Income

- a) Under IndAS 109, Interest income is recognised by applying the Effective Interest Rate (EIR) to the gross carrying amount of financial assets other than credit-impaired assets and financial assets classified as measured at fair value through Profit and loss (FVTPL).

(3) Dividend Income

Dividend income is recognised when it is actually received

- a. When the right to receive the payment is established.
- b. it is probable that the economic benefits associated with the dividend will flow to the entity and
- c. the amount of the dividend can be measured reliably

(4) Taxes

Current tax

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates and laws that are enacted or substantively enacted at the Balance sheet date.

Current income taxes are recognized in profit or loss except to the extent that the tax relates to items recognized outside profit or loss, either in other comprehensive income or directly in equity. Management periodically evaluates position taken in the tax returns with respect to situations in which applicable tax regulations are subjected to interpretation and establishes provisions, where appropriate.

(5) Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit.

(6) Property, plant and equipment

Property, plant and equipment are stated at cost, net of recoverable taxes, trade discount and rebates less accumulated depreciation and impairment loss, if any. Such cost includes purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for its intended use, net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the assets.

Depreciation

Depreciation is calculated as per the estimated useful life of assets prescribed by the Schedule II to the Companies Act 2013.

Derecognition of assets

An item of property plant & equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset is included in the income statement when the asset is derecognised.

- (7) Trade Investments are the investments made to enhance the Company's business interests. All other investments other than trade investments are either classified as current or long-term, based on Management's intention at the time of purchase. Current investments are valued at lower of cost or Net Realised Value / Market Value Categorywise. Long term investments are valued at cost less permanent diminution, if any, of each investment.

(8) Intangible assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated amortisation and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use and net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the intangible assets.

Derecognition of assets

An item of intangible asset and any significant part initially recognized is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset is included in the income statement when the asset is derecognized.

- (9) Contingent Liabilities, if any are not provided for in the accounts and are shown separately in Notes on Accounts.
- (10) Under the previous Gaap, non-current investments were stated at cost or NRV whichever is lower where applicable, provision was made to recognise a decline, other than temporary, in valuation of such investments. Under IndAS, equity instrument [other than investment in subsidiaries, joint ventures and associates] have been classified as Fair Value through Profit /Loss(Retained Earnings) through an irrevocable election at the date of transition. Further, under previous GAAP, joint ventures were consolidated using 'proportionate consolidation' method. Under IndAS, joint ventures have been accounted using 'equity method'

- 3 Accounting Policies not specifically referred to or otherwise are consistent and in consonance with generally accepted accounting principles keeping in view IND-AS.
- 4 The Financial Statements have been prepared as per schedule III; Division III of the Companies Act 2013 following Companies (Indian Accounting Standard) Rules 2015 on NBFC. The company has adopted Indian Accounting Standards (IND-AS) with effect from 1st April 2019 and effective date of such transition is 1st April 2018. The results have been prepared in accordance with the Companies (Indian Accounting Standard) Rule, 2015 (INdAs) prescribed under section 133 of the Comanies Act 2013 and other recognised accounting practices and policies to the extent applicable.
- 5 Information required pursuant to Schedule III Division III of the Companies Act 2013 and IND-AS have been given to the extent applicable to the activities of the company.
